On 11/7/2020, at approximately 0453 hours, Deputy D. Garcia ABN 249274 conducted a traffic stop at Waters Av W / Woodland Corporate Bl on a white Nissan bearing FL tag NPZM89 (VIN:JN8AT2MV0HW251398) for driving without headlights activated after sunset. Deputy Garcia observed the defendant operating the vehicle and detected signs of impairment. Affiant responded to the scene, detected an odor of an alcoholic beverage emanating from her breath, her eyes were bloodshot and glassy, and she was lethargic. Affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs) which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant refused to provide a lawful breath sample to determine her breath alcohol content (BrAC). The defendant was identified via FL DL. The defendant was given a DUI citation AD0BUYE which reflects the DUI charge. The defendant also received Uniform Traffic Citation ADTEG7E for Driving Without Headlights After Sunset.
