at approximately 11:45 PM, at TAMPA ROAD / FOREST LAKES BLVD, in Pinellas County did:

REASON FOR STOP: DEPUTY VANDER MOLEN WAS HEADED WEST ON TAMPA ROAD AT FOREST LAKES BLVD, THROUGH A STEADY GREEN LIGHT. DEPUTY VANDER MOLEN OBSERVED A BLUE NISSAN SUV FAIL TO STOP AT STEADY RED LIGHT, WHILE HEADING SOUTH ON FOREST LAKES BLVD AT TAMPA ROAD. THE NISSAN SLOWED NEAR THE CENTER OF THE INTERSECTION, THEN MADE AN ABRUPT TURN TO HEAD WEST OF TAMPA ROAD, NEARLY STRIKING THE MEDIAN CURB. 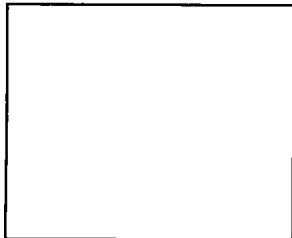
