Walsh 7916 that he/she saw the arrested person commit the below acts. [x] was found to have committed the below acts, resulting from my (described) investigation. On the 04th day of December 20 19 at 3:00 [] A. M. [x] P. M. (Specifically include facts constituting cause for arrest.)

On 12/02/2019 at approximately 1300 hours I arrived at the Home Depot store located at 9820 Glades Road in unincorporated Boca Raton, Palm Beach County, Fl. 33434 to conduct a follow-up investigation of a suspicious person and possible retail theft incident that occurred at this Home Depot store on 11/22/2019. Upon my arrival I met with the store Loss Prevention Officer identified as Stephen Fazekas to assist him in investigating the 11/22/2019 suspicious person incident involving Evan Weisberg. Mr. Fazekas accessed the Home Depot store video surveillance and he and I viewed store surveillance which was date and time stamped as 11/22/2019 at approximately 1120 hours and the video revealed the following:

On 11/22/2019 at approximately 1120 hours a white male subject wearing a short sleeve camouflage t-shirt, blue jean pants and black sneakers is observed entering the Home Depot store from the north entrance with nothing in his hands. This white male subject, positively identified as Evan Weisberg, is then observed as he walked directly to the power tool displays and selected a Dewalt brand model DCK278C2 drill kit with a retail value of \$149.00 excluding sales tax. Mr. Weisberg is then clearly observed as he walks southbound inside the store with his head bowed forward to obscure his face from the cameras and passes all open and available points of sale and exits the Home Depot store through the center entrance/exit doors with the stolen Dewalt brand drill in his possession. Mr. Weisberg was inside the Home Depot store for approximately one minute. Mr. Fazekas completed a sworn written statement and wrote that Home Depot would prosecute the offender. Mr. Fazekas provided me with a copy of the Home Depot store surveillance from 11/22/2019 which was placed on a thumb drive and entered into PBSO evidence along with a copy of the Home Depot store receipt of the stolen Dewalt drill kit. Also entered into evidence was a copy of the still photo taken of Evan Weisberg taken during the suspicious incident that occurred in this same Home Depot parking lot on 11/30/2019 where Mr. Weisberg was dressed in the same clothing. I accessed the RAPID's secondhand dealer database and a check of Evan Weisberg's pawn history revealed that Weisberg had pawned the exact same Dewalt brand model DCK278C2 drill kit at American Pawn in Boca Raton, Fl. approximately 30 minutes after Weisberg was observed stealing the same Dewalt model drill from this Home Depot store. A check of the traffic website Mapquest revealed that the distance between the Home Depot store at 9820 Glades Road and the American Pawn at 439 NE 20th Street is approximately 8.4 miles in distance and averages 20 minutes in normal driving time.

On the 04th day of December 20 19 at 3:00 [] A.M. [x] P.M. (Specifically include facts constituting cause for arrest.)

Based on the information gathered during this investigation the suspect was positively identified as Evan W. Weisberg. A photo array was created using a black and white photo of Evan W. Weisberg and black and white photos of five similar looking subjects which were randomly placed in the photo array. On 12/04/2019 at approximately 1345 hours I arrived at the American Pawn secondhand dealer store located at 493 NE 20th Street in the City of Boca Raton, Palm Beach County, FL 33431 where I met with the store owner identified as Armen Grigoryan. Mr. Grigoryan stated that there was no saved video surveillance at his store and completed a PBSO Pawn Shop Affidavit and wrote in the affidavit that on 11/22/2019 at approximately 1145 hours a white male subject identified as Evan W. Weisberg had entered his store, presented his Florida Driver License, (W216-219-95-171-0) with a photo of Weisberg's likeness and pawned a Dewalt brand model DCK278C2 drill kit in the original unopened box. The sale of the Dewalt drill was documented on Florida Pawnbrokers Transaction form numbered 201901767 in exchange for a payment to Weisberg of \$80.00 in U.S. Currency. Mr. Grigoryan added that Mr. Weisberg was a semi-regular customer at his business and had recently pawned several pairs of new sunglasses. I completed a PBSO property receipt and later placed the Florida Pawnbroker Transaction Form numbered 201901767 provided by Mr. Grigoryan into evidence with a request to have a latent print examination performed on the thumb print located on this document and a comparison to Evan W. Weisberg's known print. The Pawnbroker Transaction form also had a signature on the bottom pledger/seller line that matched the known signature of Evan W. Weisberg. Mr. Grigoryan was then asked to attempt to identify the subject from a photo line-up. He was read the Photo Array witness instructions aloud by D/S Vasconcelos/23113 and verbally stated that he fully understood the Photo Array instructions. Mr. Grigoryan signed and dated the Photo Array Folder acknowledging his understanding of the instructions. Mr. Grigoryan was then given the closed Photo Array folder which he opened and viewed the enclosed photo lineup. Mr. Grigoryan positively identified Evan W. Weisberg, who was listed in the number five position in the photo array, as the same person who pawned the Dewalt brand model DCK278C2 drill kit on 11/22/2019 at 1151 hours in reference to Florida Pawnbrokers Transaction number 201901767 in exchange for a payment of \$80.00 in U.S. Currency. It should be noted that Evan Weisberg was seen on Home Depot video surveillance stealing this same model Dewalt drill from the Home Depot store at 9820 Glades Road on 11/22/2019 at approximately 1120 hours and is documented selling this same model Dewalt drill to the American Pawn store at 1151 hours.
