<p>On August 25, 2010, at 1400 hours, the School District of Palm Beach County School Board called to order a special meeting. At the start of the meeting, the Board Chair read a statement to all gathered regarding the conduct that was expected during the meeting i.e. no shouting, no standing, no talking out of turn, etc. The defendant acted against the required conduct by refusing to take a seat during the meeting. The Board Chair directed those gathered to please take a seat and the defendant refused. The Board Chair then directed School District of Palm Beach County police officers to remove all persons not complying with the directives. School District of Palm Beach County Police Officer's, in uniform, approached the defendant and asked him to take a seat, he refused. I, dressed in full police uniform, approached the defendant and again asked him to take a seat, but the defendant again refused. After several requests and continued refusal by the defendant to take a seat, the defendant was ordered to leave the building. The defendant refused to comply with the order to leave.</p> <p>The defendant stood directly in front of the exit door with his arms crossed which also prevented others from leaving the room. The defendant was warned several times that he was trespassing and that if he did not comply, he would be arrested. The defendant stated again he was not leaving. The decision was made to take the defendant into custody. I grabbed the defendant's right arm and stated he was under arrest. The defendant refused to comply with officers' efforts to handcuff him by bracing his arms. Again, the defendant refused to comply and was forcibly pushed out the exit door. As uniformed officers attempted to handcuff the defendant, he continued to resist arrest by flailing his arms, pulling away, and kicking his feet. During the arrest, Officer Baker was cut above his right eye. With the assistance of several officers, the defendant was taken into custody and transported to the Palm Beach County Main Jail.</p> <p>The defendant did knowingly disrupt and interfere with the lawful administration and function of the school board, on school board property, contrary to Florida Statute</p>
