

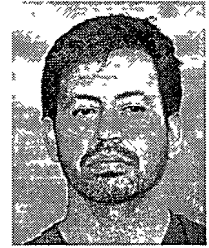

Before me this date personally appeared SERPHOS, STEVEN (17432) who being first duly sworn deposes and says that on 27 day of April, (year) 2017 at 3999 W COMMERCIAL BLVD/N SR 7, TAMARAC, FL 33309 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Upon arrival I made contact with Deputy B Amaras #18017 He advised that m that he was investigating the traffic crash at that location and that five vehicles were involved He also advised me that the driver of V2 was transported to the hospital by Fire Rescue with lower back pain He stated that while making contact with the driver of V1 he observed signs of impairment including that he could not provide requested documents, he was falling asleep, and he urinated on himself He also stated that the driver told him that he was coming from Las Olas and had a couple of drinks. Deputy Amaras completed a sworn DUI supplemental report and the traffic crash report.

During my independent observations of the scene I observed that all vehicles had been removed from the roadway and were in the CVS parking lot at the corner V1 (FL/988LVZ black BMW 4D) had damage to the front end V2 [REDACTED] had damage to the rear end V3 [REDACTED] had damage to the rear end V4 [REDACTED] had damage to the rear end V5 [REDACTED] had damage to the passenger side

I then made contact with an independent witness whom I identified as [REDACTED] She advised me that she saw the crash occur and she provided a sworn written statement outlined what she saw.

I then made contact with [REDACTED] who was involved in the crash and saw the driver of V1 driving at the time of the crash He pointed the driver of V1 out to me on scene and he completed a sworn witness statement

I then made contact with driver of V1 Upon making contact with him I observed that

Before me this date personally appeared SERPHOS, STEVEN (17432) who being first duly sworn deposes and says that on 27 day of April, (year) 2017 at 3999 W COMMERCIAL BLVD/N SR 7, TAMARAC, FL 33309 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

his eyes were bloodshot and watery I advised him that the civil crash investigation was complete and that I was beginning a criminal DUI investigation. He stated that he understood As he spoke I was able to detect the odor of an unknown alcoholic beverage coming from his breath

He stated that he was coming from Club Yolo in Las Olas and that he was now on his way to Wellington He stated that he was going to take 595 and then go south on the Turnpike which was not consistent with his location He also appeared to be unsure of where he was. He stated that he consumed two drinks with vodka

He stated that he does not have any medical problems or physical defects/disabilities He stated that he is not sick or injured and that he does not take any drugs or medications. He stated that he does not have diabetes or epilepsy. He stated that he does not have any problems with his eyes and that he does wear contact lenses but not glasses

I then asked him if he would consent to field sobriety exercises which he did. The exercises were done in the roadway which was flat, well lit, and free from debris

HGN During this exercise I observed equal pupil size and equal tracking. I then observed lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes, and onset of nystagmus prior to a 45 degree angle in both eyes VGN was present He was swaying throughout the exercise

Walk and Turn During this exercise I observed him move from the instructed position,
