He stated that he As he spoke I was able to detect the odor of an unknown alcoholic beverage coming from his breath He stated that he was coming from Club Yolo in Las Olas and that he was now on his way He stated that he was going to take 595 and then go south on the Turnpike which was not consistent with his location He also appeared to be unsure of where he was. He stated that he consumed two drinks with yodka He stated that he does not have any medical problems or physical defects/disabilities He stated that he is not sick or injured and that he does not take any drugs or medications. He stated that he does not have diabetes or epilepsy. He stated that he does not have any problems with his eyes and that he does wear contact lenses but not glasses I then asked him if he would consent to field sobriety exercises which he did. exercises were done in the roadway which was flat, well lit, and free from debris During this exercise I observed equal pupil size and equal tracking.
