The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a gray Ford Mustang (FL Q1BM44) that was observed talking to the driver of a yellow Ford Mustang (999GT) on Palm Av / 21st St N. They signaled to each other before getting on I4 WB from 21st St N. Both vehicles sped off at a high rate of speed topping 75 MPH before the defendant made a last second lane change to get onto I275 NB and pulled behind the yellow Mustang. Both vehicles sped up to over 100 MPH and made quick lane changes and appeared to be engaged in a contest of speed. The yellow mustang was in the lead and they jockeyed for position. They displayed a wanton disregard for the safety of others as they swerved around slower moving vehicles. The gap widened between both vehicles with the gray mustang trying to gain ground on the yellow one. I activated my emergency lights to effect a stop after our speeds topped 110 MPH. The gray Mustang stopped but the yellow one didn't. The driver, Faith Vannes was arrested for street racing. Her identity was verified using her Florida drivers license.
