Narrative:

I responded to the area of Sealofts located at [REDACTED] Palm Beach County, Florida, 33426 in reference to a disturbance. While enroute, the caller, later identified as Victim 1 advised via recorded line that he was holding a female, later identified as Fallon O'Connor, inside of a bedroom to keep her from leaving before officers arrival.

Upon arrival, I met with Victim 1 and O'Connor, who both advised that they were in an altercation. Upon speaking with O'Connor, she advised that she was asleep when Victim 1 looked through her phone and woke her up to question O'Connor about people she was texting. O'Connor advised that Victim 1 then threw her phone at her face. O'Connor advised that upon speaking with Victim 1, he began to throw her belongings around the apartment and out of the closet while asking O'Connor to leave. O'Connor advised that she attempted to gather some belongings at which point Victim 1 shut the door to the bedroom and would not let go or let O'Connor out. O'Connor advised that asked Victim 1 multiple times to let her out of the bedroom but he would not. O'Connor advised that she banged on the bedroom door multiple times with her fist. O'Connor advised that Victim 1 eventually let go of the door, at which time O'Connor went into the living room and threw a vase at Victim 1. O'Connor advised that she attempted to leave the apartment at which time Victim 1 started to hold her down to prevent her from leaving. O'Connor advised that once freed she thinks she threw Victim 1's keys out of the apartment. O'Connor advised that she then left the apartment and tried to run away while Victim 1 followed her through the parking lot until met with officers.

I observed O'Connor to have no physical injuries to her face but I did observe a red mark to her left knee. Additionally, O'Connor was able to show officers a video of her trying to pull on a door handle while yelling frantically at Victim 1 to let her out. Please note that the video went on for approximately one minute of O'Connor being locked in the bedroom.

I then spoke with Victim 1 who immediately advised that he held O'Connor in the bedroom for approximately 3 seconds because she is known to run. Victim 1 advised that he and O'Connor were asleep when he kept hearing her phone go off from guys texting her. Victim 1 advised as he and O'Connor were arguing she threw all of his items off of the counter, including a vase. Victim 1 advised that O'Connor then picked up a piece of the vase and threw it at Victim 1's face. Victim 1 also advised that O'Connor clawed him in the neck area. Victim 1 advised that at this point O'Connor went into the bedroom at which point Victim 1 closed the door and held O'Connor inside. Victim 1 advised that he then released O'Connor and followed her out of the apartment to the parking lot until officers arrival. I observed Victim 1 to have a small cut to the left side of the face and scratch marks on both side of his neck.

Based on the above information, it is clear that O'Connor was held against her will by Victim 1 during the altercation although he had no legal right to do so. Additionally, it is also clear that a vase was thrown at Victim 1 at some point during the altercation. At this time, I am unable to determine the primary aggressor of the altercation, therefore both parties were arrested as mutual combatants.

At this time, based on the above information, Probable Cause exists to charge Fallon O'Connor with Aggravated Battery pursuant to Florida State Statute 784.045 (1A)1. O'Connor was transported to BBPD for processing and then to PBCJ for booking.
