The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 04 day of JANUARY, 2020,

at approximately 9:57 PM, at 2303 OXFORD CT, in Pinellas County did:

DID ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE, OR CAUSE BODILY HARM TO COREY SCOTT AGAINST THEIR WILL, THE DEFENDANT WHO HAS ONE PRIOR CONVICTION FOR BATTERY, AGGRAVATED BATTERY, OR FELONY BATTERY, 08/31/2017

THE DEFENDANT AND THE VICTIM GOT INTO AN ARGUMENT DUE TO THE VICTIM WANTING TO LEAVE THE OCCURRED. THE DEFENDANT DID NOT WANT THE VICTIM TO LEAVE AT WHICH POINT THE DEFENDANT STARTED STRIKING THE VICTIM AND SCRATCHING THE VICTIMS MULTIPLE TIMES. THE VICTIM STATED AFTER SEVERAL ATTEMPTS TO GET THE DEFENDANT OFF HIM, HE MANAGED TO PUSH THE VICTIM OUTSIDE THE ROOM THE INCIDENT WAS OCCURRING IN AND CLOSED THE DOOR. THE DEFENDANT THEN PROCEEDED TO KICK THE DOOR OPEN BREAKING THE DOOR JAM AT WHICH POINT THE DEFENDANT CONTINUED TO ATTACK THE VICTIM CAUSING A SMALL ABRASION TO HIS LEFT KNEE, SCRATCHES MARKS THROUGHOUT HIS BODY, AND A SMALL ABRASION TO THE LEFT SIDE OF HIS NECK.

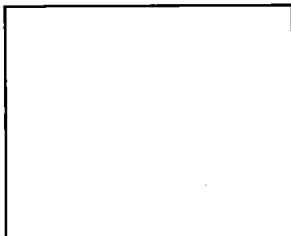
