The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law. [] committed the below acts in my presence. [] confessed to admitting to the below facts. [X] was observed by Karim who told Law Enforcement that he/she saw the arrested person commit the below acts. [X] was found to have committed the below acts, resulting from my (described) investigation. On the 28th day of March 2020 at 0010 [] A.M. [X] P.M.

On 03/28/2020, at approximately 0010 hours, Deputy Brian #4038 and I responded to [redacted] in reference to a domestic disturbance in progress at the location mentioned above. While en-route, PBSO dispatch advised the complainant stated his mom grabbed a broom at one point and broke the broom in half. Upon arrival, I made contact with the mother outside of the address mentioned above, who was identified by her Florida Driver's license as Fatme Darwiche. Fatme was upset and stated her son, the complainant, and victim, later identified as Karim Darwiche, attempted to hit her with a broom. I told her to go back to the residence in order to start my investigation. I asked Karim to step outside while Fatme returned inside the residence.

Karim provided a sworn videotaped statement, which I utilized my assigned patrol vehicle asset #68607 in-dash car video to record the interview, which I later classified and uploaded for evidence.

The following is a brief synopsis of the interview for a detailed account of the interview refer to the recorded statement: Karim stated he was in the kitchen eating when his mother, Fatme approached me very aggressively and ordered him to go to his room. At that point, Karim advised his mother to become even more upset and started screaming and yelling at him to a point where she grabbed a broom and attempted to attack him with the broom. Karim stated his father, later identified as Emade Darwiche, got woke up by the noise and came to the kitchen as well. Karim stated Fatme had been an abusive mother since his a kid, and tonight he was afraid because of her actions and anger. Karim advised Fatme to approach him aggressively, and Edame came between them and grabbed Fatme in order to stop her from trying to hit him with the broom. Karim further added Fatme was striking objects so hard in the kitchen, resulting in the broom breaking in half. I then asked Karim if Fatme struck him with the broom, and he answered, "My father came between us and grabbed her in order to prevent her striking me, and while my father was holding my mother; he cut his hands because my mother was swinging the broom at me." Karim advised he was in fear and scare over his mother's actions. Karim also advised Fatme had hit him two days ago, but he did not call the police.

After speaking with Karim, I proceeded and made contact with his father, Edame who also provided a sworn videotaped statement, which I utilized my assigned patrol vehicle asset #68607 in-dash car video to record the interview, which I later classified and uploaded for evidence.

The following is a brief synopsis of the interview for a detailed account of the interview; refer to the recorded statement: Edame stated his wife, Fatme, got upset with his son, Karim because he was making noise in the kitchen while he was eating. Edame advised his wife got upset because Karim refused to obey her commands to finish eating inside his room. Edame advised at one point during the verbal altercation Fatme grabbed a broom and started to hitting objects in the kitchen. Edame at first stated he got between his Fatme and Karim because he was afraid of Fatme was going to hit and hurt Karim. I asked Edame if Karim tried to hit his Fatme. Edame answered, "No, he was just talking with her."

<p>After speaking with Edame, I advised him to return inside his residence in order to continue my investigation with Fatme. I read the defendant her Miranda rights from PBSO pre-printed card, which she indicated she understood, and he signed the Miranda card. I proceeded my investigation.</p> <p>Fatme provided a sworn videotaped statement, which I utilized my assigned patrol vehicle asset #68607 in-dash car video to record the interview.</p> <p>The following is a brief synopsis of the Fatme's interview for a detailed account of the interview refer to the recorded statement: Fatme advised Karim had returned from college two weeks ago, and he does not follow directions. Fatme advised Karim always disobey her, which Karim never follows the rules. Fatme explained she was very upset because she pays all the bills in the house, and tonight Karim refused to obey her. Fatme stated she got upset and grabbed the broom. I then asked what happened after she had grabbed the broom. Fatme answered, "I don't remember. I got a cut on my leg." Later, she admitted trying to hit Karim but kept stating that the broom did not touch her.</p> <p>Based on my investigation, Karim, Edame, and Fatme's sworn taped statements, broken broom. Fatme and Edame conflict's statement, and lack of injuries on her. I conclude that Fatme Darwiche was the primary aggressor who violated Florida State Statute 784.021(1)(a) Aggravated Assault with Deadly Weapon (Broom) domestic against Karim. Fatme was placed under arrest at 0143 Hours. The Handcuffs were double locked and checked for proper fit.</p> <p>Fatme was transported to the District for paperwork and subsequently to the Palm Beach County Jail for booking.</p> <p>During my interaction with Karim, I did not observe any injuries on him. Edame had a superficial cut on his right had, which Edame advised he received the cut from holding the broom. Fatme had a superficial cut on her right leg, which indicated was self inflicted while she was swing the broom after the broom had broken in half.</p> <p>A Domestic Violence Probable Cause Supplement, Victim Notification Form, and a Case Information Sheet were all completed. Karim was also provided a copy of the Victim's Rights Brochure that was explained to him, and he signed for.</p> <p>I contacted the PBSO hot line Level II domestic violence via the portal page in regards of the incident.</p> <p>I completed a Log entry, and I also requested a copy of the 911 recording to be uploaded into STAC.</p> <p>This case is clear by an arrest.</p>
