The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the above listed date and time, at the above listed location, Sergeant Dauphin #45309 made contact with the defendant on a welfare check after observing a white Mercedes SUV (FL:BBFV42) swerving and driving up onto the median. Upon contact with the defendant indicators of impairment were observed to include bloodshot, glassy eyes, an unstable balance, thick, slurred speech, and the odor of an alcoholic beverage was detected on her breath.
