at approximately 4:30 AM, at 14983 ALAN CT, in Pinellas County did:

ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE BRIAN VANEK, HER BOYFRIEND AND CO-HABITANT, AGAINST THE WILL OF BRIAN VANEK, TO WIT: PUSHED HIM WITH HER HANDS.

DEFENDANT AND VICTIM ARE BOYFRIEND/GIRLFRIEND AND LIVE TOGETHER. THEY HAVE BEEN TOGETHER SINCE MARCH 2019. THEY ARE IN THE PROCESS OF BREAKING UP AND DEFENDANT IS REPORTED TO BE MOVING OUT SOON. DEFENDANT WENT OUT DRINKING DURING THE NIGHT AND RETURNED AT 0430 HOURS, AND COULD NOT GET IN DOOR. DEFENDANT WAS ANGRY WITH VICTIM BECAUSE OF THE RELATIONSHIP AND AN ARGUMENT ENSUED. DEFENDANT WAS INTOXICATED. VICTIM VIDEO RECORDED DEFENDANT BEING AGGRESSIVE AND PUSHING VICTIM SEVERAL TIMES. POLICE WERE CALLED. AT THAT TIME VICTIM WAS NOT COOPERATIVE WITH POLICE AND WOULD NOT PROVIDE VIDEO. DEFENDANT LEFT RESIDENCE AND RETURNED AT 0730, STARTING UP THE ARGUMENT AGAIN. DEFENDANT STRUCK VICTIM WITH AN UNKNOWN OBJECT. VICTIM CALLED POLICE AGAIN. YOUR AFFIANT OBSERVED A SMALL MARK ABOVE VICTIM'S RIGHT EYE. DEFENDANT DENIED COMMITTING THE SIMPLE BATTERY. DEFENDANT WAS DETERMINED TO BE THE PRIMARY AGGRESSOR AND WAS ARRESTED.

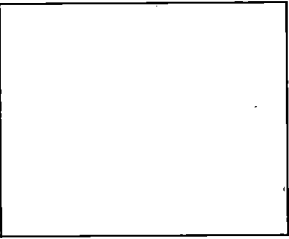
