The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a blue 2015 Nissan Versa (FL TAG #GVEX40) westbound on Platt St W, approaching me head-on in the left lane at Armenia Av S. During the traffic stop for the wrong-way infraction, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, droopy eyelids, slurred speech, appeared to be sleepy/lethargic, moved with slow & deliberate movements, had fumbling fingers, was confused & disoriented, admitted to drinking "1 glass of red wine", and emitted a distinct odor of an alcoholic beverage from his breath. He was arrested for DUI following a poor performance on SFSEs. While at CBT, he refused to provide a breath sample, despite being read Implied Consent.
