

	Based on this Officers observations, Doran was asked to exit the vehicle to participate in Standardized Field Sobriety Exercises, to which she complied. Doran leaned against the vehicle when she exited the vehicle. Doran said she did not have any medical conditions which would affect the exercises performed.
	The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used, was a Toxoptix X3. Doran had to be instructed twice to look at the stimulus rather than the flashlight. Doran did not follow instructions, rather, she would close her eyes, look elsewhere, and not follow the stimulus. This Officer determined Doran was too impaired to properly follow instructions.
PROBABLE	The second exercise conducted, was the Walk and Turn. The line used, was a strip of yellow tape placed upon the pavement by this Officer. During the instructions, Doran exited the starting position four times and started prior to being told to do so. During the first set of steps, Doran raised her arms more than six inches from her sides and took 12 steps rather than nine. Doran conducted an improper turnaround by way of coming off the line and walking around. During the return set of steps, Doran again raised her arms more than six inches from her sides and took 10 steps rather than nine.
CAUSE STA-	The final exercise conducted, was the One-Leg Stand. Doran raised her right foot. During the exercise, Doran placed her foot down the first time and left it on the ground while continuing to count. Doran was then instructed to raise her foot. Doran swayed throughout the exercise and raised her arms more than six inches from her sides. Doran hopped two times and placed her foot down two more times, which ended the exercise early.
TEMENT	Based on this Officers observations, Doran was placed under arrest at 2339 hours. An inspection of the vehicle showed the driver side front tire and driver side rear wheel well had dirt and grass as if the vehicle had recently been driven off the roadway. While on the way to the PBSO BAT, Doran vomited in the back seat of unit #16474. Upon arrival at the PBSO BAT, this Officer and Ofc Kahn 545 conducted a 20 minute observation period of Doran, to which she vomited three times into a garbage can. Each time Doran vomited the 20 minute observation period started over. The third instance was after Doran and Officers were already at the PBSO BAT for approximately 45 minutes, which was also approximately 90 minutes after the arrest. This Officer elected to bring Doran into the recorded room, to inform her of Florida Implied Consent, since she had previously also informed this Officer she would not provide a breath sample. On camera, this Officer read updated Florida Implied Consent to Doran, to which she acknowledged and refused at 0102 hours. 
