

Jupiter FL 33458 (Old Florida Bar and Grill), in reference to a female causing a disturbance. Upon my arrival I made contact with the manager Charles Snyder (W/M 10-14-64), who advised that a white female wearing a blue polo shirt, was causing a disturbance at the bar. He advised that she had brought alcohol into the bar and was asked to leave. He advised that she began screaming and acting irate, while throwing items over the bar. He advised that she left the establishment just prior to police arrival. He advised that he wanted her trespassed from the property indefinitely.</p> <p>Contact was made with a white female matching the description, next door to Old Florida Bar and Grill. She was identified as Florence Buscemi (W/F 5-16-97). She was agitated and speaking erratically. I advised Buscemi that she was being trespassed from the establishment indefinitely. She stated that she understood and would not be going back. She then stated that she would call for a ride. She then stated that she would walk home. Then Buscemi stated that she could not be trespassed unless she signed a piece of paper. She was advised of how a trespass warning is issued, and she did not believe that she could be trespassed without a piece of paper. At that point, Buscemi was free to leave the area, but chose to walk on the sidewalk and stop in front of the business, antagonizing staff and patrons by continuously waiving her hands in front of the windows. She then yelled to a patron leaving the bar to "suck her fucking dick". Shortly after, she walked up to the front door and began waiving her hands.</p> <p>Based upon my above described investigation, I found probable cause to arrest Buscemi for TRESPASS ON PROPERTY OTHER THAN A STRUCTURE OR CONVEYANCE AFTER WARNING as Buscemi did unlawfully, without being authorized, licensed, or invited willfully enter upon or remain on the property of Old Florida Bar and Grill, as to which notice against entering or remaining was given, either by actual communication or by posting, or fencing or cultivation as described in 810.011, {or} did, without being authorized, licensed, or</p>



<p>invited, willfully enter upon or remain in any property other than a structure or conveyance, the property of Old Florida Bar and Grill, said property being the unenclosed curtilage of a dwelling and Buscemi entered or remained with the intent to commit an offense thereon, other than the offense of trespass and did defy an order to leave, personally communicated to the offender by the owner of the premises or by an authorized person, contrary to Florida Statute 810.09(1)(a), (2)(a), (2)(b).</p> <p>I advised Buscemi that she was under arrest for the above mentioned charge and I placed her into handcuffs behind her back, checked for proper spacing and double locked them. As I was escorting Buscemi to my patrol vehicle, she began bracing and tensing her arms, while trying to pull away. She then tried to throw herself to the ground multiple times. After standing her up, Officer Shaff completed a search of her person. After the completion of the search, while trying to place Buscemi into the back of my patrol vehicle, she began kicking at my open patrol vehicle door. Buscemi then began trying to pull away from the vehicle while jumping up and down multiple times and flailing her legs. Buscemi was ultimately escorted to the ground where a hobble was placed around her ankles to keep her from kicking. She was then placed into my patrol vehicle and transported to the Jupiter Police Department holding area to complete arrest paperwork.</p> <p>Based on her actions after being placed into handcuffs, I found probable cause to additionally charge Buscemi with RESIST OFFICER WITHOUT VIOLENCE as Buscemi did resist, obstruct or oppose Officer Matonti, a law enforcement officer of the Jupiter Police Department, in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, contrary to Florida Statute 843.02.</p> <p>While being positioned into the holding cell, Buscemi continued to be uncooperative, therefore she was placed into the holding cell while still handcuffed behind her back. She then slipped her arms underneath her legs to place the handcuffs in front of her. After that, she removed her pants and her shoes. She began banging the cell doors while yelling and screaming. She then began throwing her shoes at the video surveillance camera located on the ceiling of the inside of holding cell #2, where she was located. Myself and Ofc. Flesch entered the holding cell to remove the shoes and pants to keep her from harming herself. While retrieving those items, I observed the housing to the video camera, broken and laying on the ground. The value of the broken housing is valued at approximately \$250.00.</p> <p>Based on Buscemi's actions inside of the holding cell, which caused property damage, I found probable cause to also charge her with CRIMINAL MISCHIEF (\$200.00 - \$1,000.00) as Buscemi did willfully and maliciously injure or damage, or place graffiti thereon, or commit an act of vandalism to a video camera, the property of Jupiter Police Department, contrary to Florida Statute 806.13(1)(a) and (b)2. (1 DEG MISD).</p>



Based on Buscemi's actions inside of the holding cell, which caused property damage, I found probable cause to also charge her with CRIMINAL MISCHIEF (\$200.00 - \$1,000.00) as Buscemi did willfully and maliciously injure or damage, or place graffiti thereon, or commit an act of vandalism to a video camera, the property of Jupiter Police Department, contrary to Florida Statute 806.13(1)(a) and (b)2. (1 DEG MISD).

It should be noted that while in the holding cell, Buscemi continued to try and force herself to vomit while spitting on the floors and walls. She was also observed to vigorously and continuously bang and slam into the holding cell door with her hands, feet and body. She then claimed to be vomiting blood. I observed blood droplets on the floor which appeared to come from a small laceration on her knee. The laceration was not present during arrest or transport, and can be assumed it was self-inflicted while slamming herself into the holding cell door. I also observed saliva on the floor and walls with a tint of blood. I requested fire rescue to respond to the station, as Buscemi was requesting medical attention. Palm Beach County Fire Rescue responded (Run # 21125396), and subsequently transported Buscemi to Jupiter Medical Center, where she was medically cleared for jail by Dr. Ventzek. I transported Buscemi to the Palm Beach County jail without further incident. I utilized my Axon body worn camera for this call for service. Sgt. Counihan photographed Buscemi's injuries and the damage to the holding cell video camera.

The following incident was captured utilizing my department issued BWC.

On Saturday, November 6, 2021 at approximately 2146hrs, I responded to Old Florida Bar and Grille (250 W Indiantown Rd, unit 101, in reference to an unwanted guest. I responded to the incident in the capacity of a backup officer.

Ofc. Matonti conducted his investigation, which ultimately lead to the issuance of an indefinite trespass to Florence Buscemi (WF 5/16/1997). Buscemi was advised of the trespass warning and continued to linger in the area, advising she was waiting for a ride. Ofc. Matonti, Pfc. Flesch and I returned to the restaurant to speak with management, and Buscemi could be heard yelling profanities from outside the business.

While inside the business, officers observed Buscemi return to the front entrance doors of the restaurant and wave through the glass door. Ofc. Matonti, Pfc. Flesch and I approached Buscemi and placed her into handcuffs, advising her that she was being arrested for trespass after warning, as she clearly returned to the business after being advised not to.

We escorted Buscemi to Ofc. Matonti's police vehicle, where she continued to yell obscenities towards officers and was acting erratic. Prior to conducting a search of Buscemi, I asked if she had anything sharp on her person that would poke, stick or stab me; to which she replied "I fucking hope so". I conducted a search of Buscemi that yielded negative results for weapons and contraband. While searching Buscemi, she was uncooperative and refused to listen to officers commands, all the while she continued to tense, brace, pull away and turn away.

After searching Buscemi, she was advised a hobble restraint would be utilized if she continued to be uncooperative. At this time, Buscemi became irate, cursing and screaming at officers while jumping up and down. She was assisted to the ground, where I utilized a hobble restraint to secure her feet, as she continued to kick, struggle, brace, and push away from officers. After her feet were restrained, Buscemi was placed into the back of Ofc. Matonti's police vehicle, where an additional seatbelt restraint was utilized to secure her.

Buscemi was transported to the JPD holding facility and was then transported to JMC by PBCFR due to her spitting blood. I accompanied Buscemi in the back of the ambulance and she was brought into JMC without incident. After medical clearance, she was turned over to Ofc. Matonti for transport to PBCJ.

That concludes my involvement in this case.

On 11/6/21 at approximately 2146 hours I responded to 250 W Indiantown Rd #101, Jupiter, FL 33458 (Old Florida Bar & Grill) in reference to a female who was refusing to leave the premise and was throwing objects at employees. While enroute, Northcom advised the caller was struck by the female causing the disturbance.

Upon arrival I made contact with the manager of the business, WM Charles L Snyder 10/14/64 who stated a white female and a couple friends had come into the bar with their own alcohol. When told this wasn't allowed, one of the females became irate and started throwing items from the bartop at employees and around the business. He then told her he was calling the police. She then struck him in the face and walked out of the bar. Snyder declined prosecution however requested the female be trespassed indefinitely.

The female causing the disturbance was located on the sidewalk a short distance from the bar by other responding officers and was identified as WF Florence J Buscemi 5/16/97. She was advised that she was trespassed indefinitely from the business and was never allowed back. She then demanded to sign a paper and she was advised there was no paper to sign. She began to argue with officers on scene that the trespass warning was not legitimate and she was assured it was. She then walked down the sidewalk towards Old Florida Bar & Grill and began pacing in front of the bar still on the public sidewalk.

Officer Matonti, Shaff, and myself went into the bar to speak with the manager and explain to him that the female had been issued the trespass warning. While we were inside, Buscemi stood on the public sidewalk and taunted both patrons and staff by stating "suck my dick". At one point she stepped on the curtilage of the bar and stood in front of the entrance doors of the bar. At this point she had violated the trespass warning she had previously been issued and was advised she was under arrest. She was placed in handcuffs and began to tense her arms during this process.

Officers Matonti and Shaff escorted her down the sidewalk to where our patrol cars were parked. As we approached the patrol vehicles, Buscemi began to scream for no apparent reason that her back was hurting and she fell to the ground. She then asked to sit up and she was assisted. She was then stood up so a search incident to arrest could be conducted prior to being placed in a patrol vehicle. At this point Buscemi became irate and started to scream that she wanted a sergeant or a lawyer. I was now maintaining control of her left arm. She continued to scream and began to resist by twisting and pulling away. She was told to stop tensing and did not comply.

Once officer Shaff had completed her search, we attempted to place Buscemi in the back of a patrol car however she kicked the door preventing us from placing her inside. She was then advised that she her legs would be tied if she continued with this behavior. She continued to argue and scream at officers. She then stated that we should tie her feet because it would be better for her. It was at this time she began to jump in the air several times while flailing her legs.

On her last jump she landed in on the ground in a seated position. We then rolled her over onto her stomach and officer Shaff used a hobble to restrain he legs and feet. We then stood her up and placed her into the back of Officer Matonti's patrol car. An upper body restraint belt was utilized to reduce her mobility and keep her from injuring herself. She was then transported to the Juptier Police Station for processing.

While at the police station, Buscemi spit into the back of and on the door of Officer Matonti's patrol car. She then advised she need to use the bathroom and threatened to urinate in the back of the car if we did not bring her to a bathroom immediately. Officer Matonti and I subsequently escorted Buscemi into the prisoner holding area of the Jupiter Police department and placed her into a cell which has a toilette. Due to her non-compliance and aggressive behavior, her handcuffs were left on. Once in the cell, she was able to move her hands from her back to her front. She then proceeded to take her pants and shoes off and throw them around. Additionally, she repeatedly kicked and hit the cell door with her boots. At one point she started throwing her boots at a security camera inside the cell and broke the housing off of the camera.

Due to her extreme aggressive behavior inside the cell, she caused an abrasion to her knee and a possible laceration inside her mouth. She also started spitting all over the floor. She then requested medical treatment and PBFR arrived. She was transported to Jupiter Medical Center and medically cleared. Officer Matonti ultimately developed probable cause to arrest Buscemi for Trespass After Warning, Resisting Without Violence, and Criminal Mischeif.
