The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
On 05-16-2020 at approximately 2207 hours, I observed the defendant operating a vessel within Hillsborough County along the Alafia River. I observed the vessel (Bearing: FL2627NS) with no all around 360 degree white light. After making contact with the operator of the vessel/defendant, he immediately plugged in his all around 360 degree white light and turned it on. I conducted a vessel stop as the defendant was operating a vessel in violation of F.S.S. 327.33. The vessel stop was also conducted for the purposes of completing a boating safety inspection. Your affiant gave verbal commands from the River Civic Center Park to the defendant. Your affiant advised him to come to the dock and secure his vessel. The defendant began erratically operating his vessel in an attempt to get his vessel closer towards the dock. I noticed he had blood shot watery eyes, slurred speech and the odor of an alcoholic beverage coming from his breath. Your affiant also observed an open beer container at the helm of the vessel. Your affiant asked the defendant to conduct SFST's which he agreed to. The defendant showed signs of impairment and was arrested for boating under the influence. After a 20 minute observation the defendant provided a breath sample of .149 and .149. The defendant was identified via DAVID and his Florida Drivers License.
