The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: I observed the defendant driving a silver Infiniti SUV with FL tag NEZI77 on the roadway. He was in a right turn only lane and went straight and then cut across three lanes of travel and made a left turn cutting off traffic that had the right of way. He straddled the lane lines and got onto I-27. He accelerated to 80 mph in a 55 mph zone. He drifted outside of the lane marker and was straddling the lane again on the interstate. I conducted a traffic stop and made contact with the defendant who was the driver of the vehicle. Upon contact I could smell the odor of alcoholic beverages from his breath. His eyes were glassy and bloodshot. He dropped his license in his lap when he tried to hand it to me. He performed field sobriety exercises and showed impairment. His breath alcohol content was .151 / .151. Defendant ID'd by FL DL.
