On 09/27/2020 the victim, Edy Cajalo Ortiz reported her car keys and vehicle stolen from her work, Girafas Sports Grill, located at 5056 Forest Hill Blvd. Deputy Williams #34315 responded and took the initial report.

I was assigned this case and asked to complete a follow up investigation. While following up with the victim, I learned from her what happened. In the early morning hours of 09/27/2020 the victim was working as a bar tender and stored her car keys behind the bar where only employees are allowed to be. During the course of her shift, several customers who the victim is familiar with came into the bar and had drinks, food and hung out with each other. Two men who have visited the establishment before approached the victim as she was working and distracted her while one of them stole her car keys.

The victim identified the suspect who took her car keys and eventually her vehicle as Franco Messina. The victim provided on-line information which shows personal information about the suspect, positively identifying him as the person seen on video taking her keys from behind the bar. After running the name Franco Messina in the Driver and Vehicle Identification Database, D.A.V.I.D. I was able to confirm that Franco Messina and the profile provided by the victim were one and the same person. The actual identity of the suspect identified by the victim is Franco Messina, White male, date of birth 11/25/1979.



When asked, the victim said she was 100% positive about the identity of the suspect, Franco Messina as the person she was distracted by and the same person she witnessed in the surveillance footage after the fact taking her car keys from behind the bar. Because of the victim's familiarity with the suspect and to make sure she was identifying the correct person as the suspect, she was shown a familiarization photograph of Franco Messina, W/M DOB 11/25/1979 from Intellitech. She immediately confirmed the person pictured was the same person who took her keys.

The victim provided surveillance footage which shows two males approach her while she was working behind the bar. The men according to the victim, distracted her and one of them, Franco Messina stole her car keys and eventually her vehicle from the parking lot. Surveillance does not show the car being taken, but does show Franco taking the keys while the victim was distracted by them.

The victim did recover her vehicle after being contacted by police. The car was left abandoned near her residence. The vehicle had no forced entry and no damage to the steering column, which proves keys were used to take it from her work.

Based on the fact that the victim was able to positively identify the suspect who distracted her, took her car keys and eventually her vehicle as Franco Messina, DOB 11/25/1979, I find there to be sufficient probable cause to arrest and charge him with violation of FSS 812.014(3a), petit theft and violation of FSS 812.014(2)(c)(6), grand theft auto.
