On 08/09/2021 at approximately 1959 hours, Deputy Cody H. Gibb ABN: 257675 contacted a black Chevrolet Impala bearing Florida Tag: QCKD12 at Tyndale Dr / Sandy Creek Dr. Deputy Cody H. Gibb observed a white Hispanic male slumped behind the wheel of the vehicle mentioned above in actual physical control. Deputy Cody H. Gibb noticed signs of impairment and requested a DUI investigator for a possible impaired driver.

Upon my arrival, I observed Frank Abreu Quintero driver, outside his vehicle with soiled clothing (jeans front zipper area). I conducted a welfare check on Frank Abreu Quintero; he refused EMS by saying "No." I immediately noticed multiple impairments signs such as unbalance on his feet, slurred speech, and a strong odor of an alcoholic beverage on his breath. I asked Frank Abreu Quintero if he would perform the Standardized Field Sobriety Exercise (SFSE's); he replied, "yes." Frank Abreu Quintero did not perform the SFSE's as instructed and demonstrated.

Due to the totality of circumstances and multiple signs of impairment, I placed Frank Abreu Quintero under arrest for DUI. I transported Frank Abreu Quintero to the HCSO Central Breath Testing (CBT) section. After the mandatory uninterrupted twenty-minute observation period ended, Frank Abreu Quintero's BrAC reflected .248 / .256. Frank Abreu Quintero identified himself via his valid Florida CDL License: A162260854660.
