The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 3/31/2021, at approximately 2025 hours, Deputy W. Marquez ABN 257643 arrived at 11435 Dale Mabry Hw N (Carraba's) in Tampa, FL in reference to suspicious vehicle call for service. The comments of the call advised a white male was parked in the to-go parking spot and was sleeping and appeared to be intoxicated. Deputy Marquez observed a grey Ford truck bearing FL tag 049RMH (VIN:1FTYR14E69PA12579) parked in the to-go parking spaces with the door open, and the keys within the vehicle. Deputy Marquez observed the defendant in the driver seat and the sole occupant of the vehicle. Deputy Marquez announced his presence, the defendant regained consciousness and advised Deputy Marquez he was "Fine". Deputy Marquez noticed several indicators of impairment during his interaction with the defendant. Affiant responded to the scene, detected the distinct odor of an alcoholic beverage emanating from the defendant's breath, his eyes were bloodshot and glassy, his speech was slurred, and was making incoherent statements. Affiant requested the defendant perform Standard Field Sobriety Exercises (SFSES) which the defendant refused to perform and was subsequently arrested for DUI. The defendant refused to provide a lawful sample of his breath to determine his breath alcohol content (BrAC). Affiant read Implied Consent to the defendant in room 1 of Central Breath Testing, he understood and replied "No." The defendant was identified via FL DL. The defendant received DUI Citation A6UW2AE which reflects the DUI charge. The defendant also received Uniform Traffic Citation AEIMKKE for Possession Of Open Container By Driver (Open bottles of vodka with liquid still inside.)
