D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 01/18/2021 at approximately 18:16hrs, I was called to the scene of a traffic stop in the parking lot of the Gator Shack located at 5088 Seminole Pratt Whitney Road, which is in the City of Westlake, Palm Beach County, Florida. I arrived at the scene at approximately 18:31hrs. Sgt. R. Nandlal #8483 relayed to me, and completed a written signed sworn supplemental Probable Cause Affidavit, that he had stopped the defendant's vehicle, a 2013 white Dodge Caravan bearing FL tag BQNS83, because the defendant effected a u-turn on a steady red traffic signal at the intersection of Seminole Pratt Whitney Road and Persimmon Blvd. Sgt. Nandlal noticed that the defendant had articulable indicators of impairment, so he called for a DUI unit to conduct a possible DUI investigation. Sgt. Nandlal identified the defendant, to me, as the driver of the vehicle, at the time of the stop.

OBSERVATION OF DRIVER:

Upon making contact with the driver who was identified by his Florida Driver License as "FRANK HENRY ATKINSON Jr., I immediately detected a very obvious and very strong odor of an unknown alcoholic beverage emitting from his person and face area prior to donning my PPE mask. This odor intensified as I spoke to Atkinson even with my PPE mask now on. Atkinson had glassy and extremely blood shot eyes. Atkinson's speech was slurred, thick, and at times difficult to understand. Atkinson's movements were slow, deliberate, and lethargic with poor coordination. Atkinson had an unsteady gait while walking to my patrol vehicle and had difficulty following directions given to him. Atkinson was wearing a blue t-shirt, faded black shorts, and sandals. All the clothing appeared neat.

DRIVER'S STATEMENTS:

Pre-Miranda: Atkinson stated he had a couple of drinks. Atkinson refused to provide a breath sample after Implied Consent, which he stated he understood. Atkinson apprehensively answered question during the Q&A portion of the interview.

ODORS:

A very strong and obvious odor of an unknown alcoholic beverage was emitting from Atkinson's person and face area.

SPEECH: Atkinson's speech was slurred, thick, and at times difficult to understand.

ATTITUDE: talkative, polite, friendly, cooperative

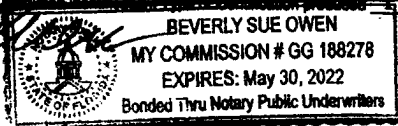

Other Observations:

Atkinson would sway roughly in a side to side front to back pattern throughout the task. Atkinson did not touch the tip of the pen as directed to positively identify the point to be tracked. Atkinson was reminded numerous times to track the pen with his eyes only. Atkinson failed to keep Atkinson head still while tracking the stimulus.

WALK & TURN:

I explained and demonstrated the instructions for the "Walk & Turn" to Atkinson who stated the he understood. During the task, I observed Atkinson to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Atkinson could not maintain his balance while listening to instructions. Atkinson stepped out of the instructional stance during the demonstration to catch his balance. Atkinson started the task before being instructed to do so. Atkinson would stop walking to steady himself with pauses to regain balance. Atkinson missed heel-to-toe steps and stepped off the line. Atkinson used his arms for balance by raising them more than six inches. Atkinson performed an improper turn by turning other than which was demonstrated.

ONE LEG STAND:

I explained and demonstrated the instructions for the "One Leg Stand" to Atkinson who stated that he understood. During the task, I observed Atkinson to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Atkinson continued to sway while balancing on one leg. Atkinson used his arms to balance raising them more than 6 inches from his sides. Atkinson put his foot down three times all before counting to 30 seconds, thusly not being able to complete the task.

FINGER TO NOSE:

I explained and demonstrated the instructions for the "Finger to Nose" task to Atkinson who stated that he understood. During the task, I observed Atkinson to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Atkinson did not keep his eyes closed and had to be reminded numerous times. Atkinson index finger did not touch the nose on 4 of 6 attempts. The sequence used for this task was L, R, L, R, R, L.

ROMBERG ALPHABET:

I explained and demonstrated the instructions for the "Rhombert Alphabet" task to Atkinson who stated that he understood. During the task, I observed Atkinson to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Atkinson would sway more than 2 inches. Atkinson correctly "sang" the alphabet with some obvious pauses.

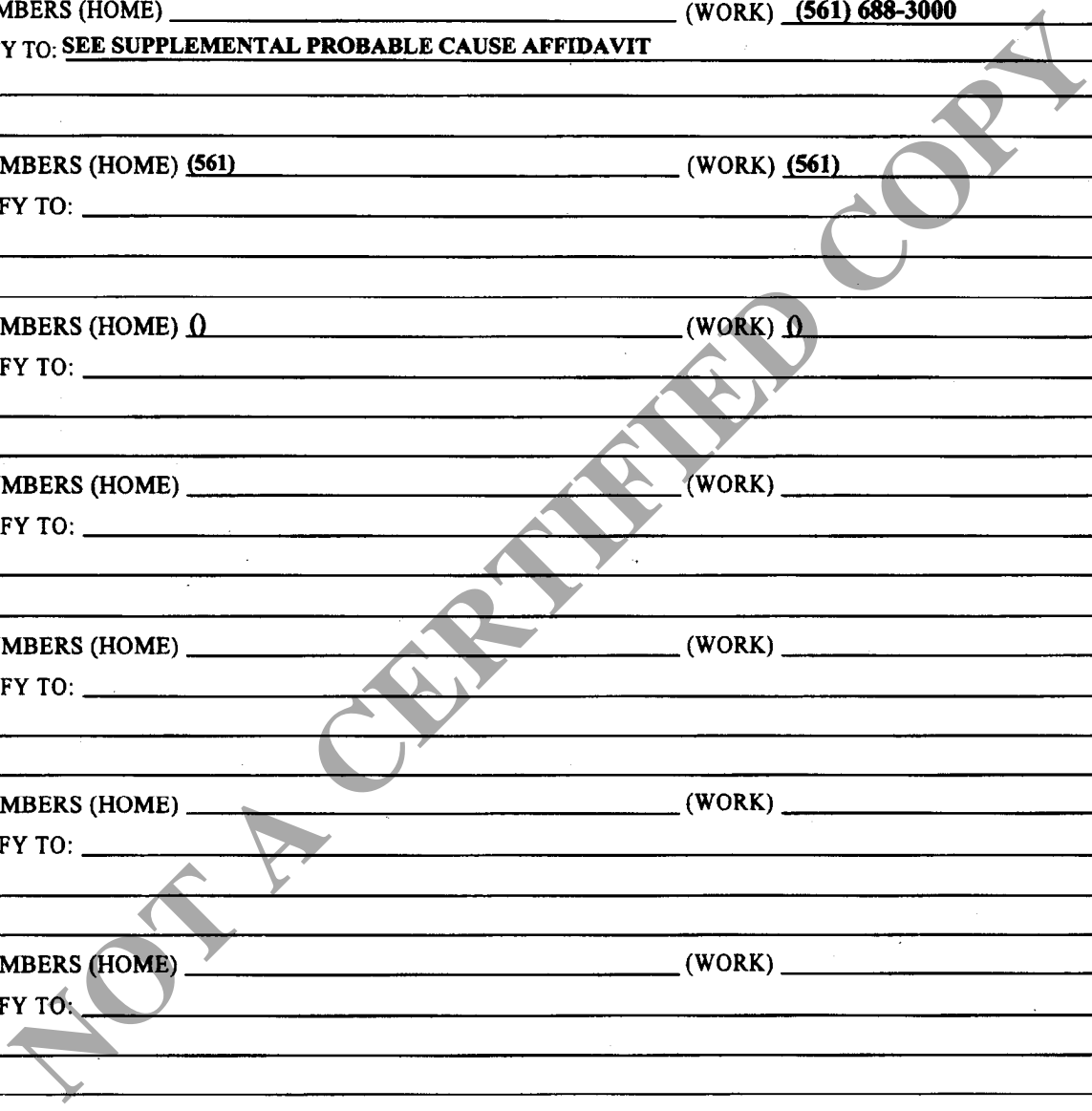

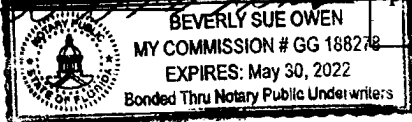
