

Upon arrival, I met with the victim, Eleni Almeida, who advised me she was jogging with her sister, Elizabeth Kouracles, when a male later identified as Frank Sinapi attacked her.</p> <p>Investigation revealed that Almeida (victim) was jogging south on NW 2nd Ave with Kouracles who was roller blading. Sinapi (Defendant) was driving north on NW 2nd Ave and started yelling at both of them that there was a curfew and they needed get inside. Sinapi then made an immediate U-turn and pulled up along side of the girls. Sinapi became more enraged that Almedia and Kouracles were outside as all parties exchanged words. Sinapi then exited his vehicle, ran around the back of the car and charged at Almeida who was on the passenger side of the car. Sinapi grabbed Almedia's hoodie and pulled it over her head, causing her vision to be obstructed. Sinapi then threw multiple closed fist punches, striking Almeida against her will. Almeida was struck in the stomach and side of her body. Almeida tried to fend of Sinapi's attack by hitting him back. During the tussle, Sinapi and Almeida both went to the ground. Almedia screamed for help at which time Kouracles tried intervening to stop Sinapi from attacking Almedia. Police then showed up and all parties were separated.</p> <p>This incident was also observed by an independent witness, Travis Musselman, who was in his vehicle directly behind Sinapi. Musselman advised he saw Sinapi get out of the vehicle and attack Almedia. Musselman has never met Almedia or Sinapi before today's incident. Musselman provided a sworn taped statement.</p> <p>Sinapi was taken into custody and charged with simple battery. Sinapi was read his Miranda Rights from a prepared text. Sinapi stated did state he hit Almeida but claims that she hit him first. While in the back of my police car, Sinapi stated his ribs were</p>

<p>hurting and was having trouble breathing due to anxiety. Sinapi was transported to Boca Raton Regional Hospital. After being medically cleared he was transported to Palm Beach County Jail. It should also be noted that Sinapi appeared to be intoxicated. He had the odor of an alcoholic beverage coming from his breath and his speech was slurred. A DUI investigation was unable to be done due to law enforcement not seeing Sinapi operate his vehicle.</p> <p>Almedia had a visible bruise on the left side of her body and back. Pictures were taken with my MVR. Almedia and Kouracles provided sworn taped statements. There is also video of Sinapi getting out of his vehicle, attacking Almedia which was recorded by Kouracles. The video was placed into evidence.</p> <p>The victim will prosecute.</p>
