The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a white 2016 Mercedes 4-door, FL tag ICU3K, and was stopped for several traffic violations. The defendant was observed driving west on Azele approaching Armenia and failed to stop prior to the stop bar (at a stop sign), the defendants vehicle quickly approached this intersection then came to an abrupt stop, nearly striking this affiants vehicle in the intersection. The defendant then proceeded to drive no less than 70 MPH in a 40 MPH zone east on Kennedy. This was paced with a calibrated and certified police vehicle (#113). The defendant drove at 70 MPH for over seven blocks. During this time the defendant was weaving back and forth in his lane. Upon making contact with the defendant he displayed multiple indicators of impairment, to include; slurred speech, bloodshot glassy eyes, an odor of an alcoholic beverage on his breath, and an admission to consuming alcoholic beverages. The defendant also exhibited multiple clues of impairment during the SFSE's and was arrested for DUI. The defendant later submitted to a breath sample which had a BrAC result of .161 and .151.

The defendant was identified with his FL DL.
