The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 7/16/2021 your affiant observed the defendant operating a tan in color Chevrolet Impala FL# KDMD33 (VIN:2G1WH52K149306045) driving through a red light North on Nebraska Av N almost striking your affiants HCSO issued marked patrol vehicle. Your affiant conducted a traffic stop and observed the defendant and sole occupant of the vehicle in the driver's seat. The defendant showed multiple signs of impairment and spontaneously admitted to drinking alcoholic beverages. Your affiant requested the defendant exit the vehicle and preform Standardized Field Sobriety Exercises, and the defendant complied. The defendant showed multiple signs of impairment throughout the exercises and was subsequently arrested for DUI. During a search of the defendant's vehicle incident to arrest your affiant located a half crushed alcoholic beverage container next to where the defendant's feet were. The container was still cold and half full. Once at Central Breath Testing, the defendant provided a lawful sample of his breath via the Intoxilyzer 8000 SN:80-003387. The samples showed 0.073 BrAC and 0.074 BrAC. The defendant was issued Uniform Traffic Citations (UTC) for the following offenses: Driving under the influence (AEVOYSE), possession of open container by driver (AEIM53E) and failure to stop at steady red light (AEVOYRE). The defendant was identified via his Florida issued driver's license B620241522830.
