**Probable Cause**

On 1/2/2021 at approximately 9:48PM I Trooper Masterson (4467) was dispatched to a scene southbound on Interstate 95 (State Road 9) south of Woolbright Road with a distressed female and the 911 caller stating the female having many outrageous outbursts. I was in route from State Road 704 (Okeechobee Boulevard). I arrived on scene at approximately at 9:56PM. Boynton Beach PD arrived on scene prior to my arrival. Boynton PD had both parties separated on scene. I observed a male standing by his vehicle with Boynton PD officer and a female sitting on the shoulder with her head in her hands sobbing with Boynton PD officer.

I spoke with the female first. The female was identified by her Florida driver license as "GABRIELLE,ELIZABETH,PEARCE" (P-620-285-94-842-0 ). Ms. Pearce had a flush face with red and watery eyes and appeared intoxicated with her head drooping low. As I spoke with Ms. Pearce she spoke with a slow cadence and slurred speech. An unknown alcoholic beverage omitted from Ms. Pearce breath while she spoke. When I asked Ms. Pearce why she was on the side of the road crying her stories continuously changed even while in the middle of a story. One story she was traveling from Wilton manors which is a city just north of Fort Lauderdale and was traveling to Pompano Beach yet she was southbound on Interstate 95 south of Woolbright road. Ms. Pearce was becoming uncooperative and yelling so I left her with Boynton Beach PD. Ms. Pearce had mood swings ranging from anger, sadness and crying, to apologetic, to sarcastic, to rude and yelling profanity.

I spoke with the gentleman that was standing with his vehicle. The gentleman was identified by his Florida driver license as "JOSE,LUIS,ESTRADA" (E-236-432-72-363-0) (WHEEL WITNESS). Mr. Estrada explained to me that he observed her

vehicle (barring the Florida tag of "KSAR87") driving in a reckless manner. He described Ms. Pearce's gray Honda traveling at high rates of speeds and traveling in and out of lanes, almost crashing into other vehicles. Mr. Estrada explained that Ms. Pearce vehicle pulled over southbound on Interstate 95 south of Woolbright and he followed her off to the shoulder to be a good Samaritan and conduct a welfare check. Ms. Pearce stated as he approached the vehicle he saw no other occupants besides Ms. Pearce in the driver seat with the vehicle still on. Mr. Estrada stated he asked Ms. Pearce for her keys due to obvious impairment. Mr. Estrada stated Ms. Pearce was uncooperative and enraged. I asked Mr. Estrada why he did not call 911 prior to her pulling over on the shoulder. Mr. Estrada stated he wanted to give her an opportunity to call for her own ride instead of the possibility of going to jail. Mr. Estrada stated he called 911 due to Ms. Pearce wild accusations towards him.

I asked Ms. Pearce to stand up. Ms. Pearce was reluctant to stand when ordered to. Ms. Pearce finally stood and walked to the front of my vehicle. At the front of my vehicle I informed Ms. Pearce that I was conducting a DUI investigation. Ms. Pearce stated she understood. I asked Ms. Pearce if she wanted to participate in voluntary field Sobriety Exercises. Ms. Pearce refused SFST. I informed Ms. Pearce that if she refused SFST that I would be basing my arrest on the observations from the scene. I informed Ms. Pearce of the observations and reiterated that I would be basing my arrest off the observations. Ms. Pearce was rude and would speak over me and continuous stated I did not know how to do my job and the Boynton Beach PD officers the same. I asked Ms. Pearce again if she would agree to participate in voluntary SFST to prove her level of sobriety. Ms. Pearce refused to perform SFST. I arrested Ms. Pearce for DUI at 10:18PM. As I attempted to apply handcuffs on Ms. Pearce wrist, Ms. Pearce snatched her arms away from myself and the Boynton Beach PD officer. Ms. Pearce attempted to turn back around and was not cooperative and resisted without violence. Ms. Pearce would move her arms away from myself and Boynton Beach PD officer during this time of arrest.

I conducted a search of Ms. Pearce and placed her in the rear seat of my patrol vehicle. Ms. Pearce was transported to the BAT (Breath Alcohol Testing

Facility). Ms. Pearce arrived at 11:06PM. During her time at the BAT she was rude to other officers and BAT technicians and was talkative. Ms. Pearce mood swings were still very prevalent. Ms. Pearce refused a breath sample and was read implied consent and refused a breath sample again on camera at 11:32PM.

Ms. Pearce was charged with DUI (316.193.1a) with a first time refusal and Resisting arrest without violence (843.02). Ms. Pearce was released to the PBSO jail with no further instance. All events occurred in Palm Beach County.





