The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a white 2017 Buick four door bearing a Michigan license plate of EAA5960. She was traveling west on Kennedy Blvd without headlights/taillights on, and made a wide left turn onto S Armenia Ave. The defendant then approached W Platt St and the light turned red but she did not stop before making another wide left turn onto W Platt St and then accelerating quickly. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, an odor of an alcoholic beverage, an admission to consuming alcohol (one shot and one gin and tonic). The defendant also admitted to smoking a marijuana blunt tonight before going to the bar (the defendant stated she was at the bar for about twenty minutes). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test, despite acknowledgment of the Implied Consent Warning. The defendant was identified by her FL DL.
