On Saturday, August 1, 2020, at approximately 1813hrs, I responded to the intersection of Central Blvd and Church St, Jupiter, FL, in reference to an Aggravated Assault involving two vehicles.



On arrival I made contact with the victim W/M Gregory Scirrotto (04/27/1959), who provided me with a sworn video recorded statement of what happened. Note the following statement is a summary and not purported to be verbatim.

It should be noted that at the time of this incident the road was wet and saturated due to rain. Gregory was occupying the driver seat of his 2012 Jeep Grand Cherokee FL Tag: 0LB, traveling north on N Central Blvd from West Indiantown Road. Gregory was directly behind a 2016 Ford Fusion, FL Tag: TQ0AR, that was traveling in the same direction. While driving, the Ford suddenly applied its brakes hard causing Gregory to have to brake quickly.

Gregory then decided to overtake the Ford and pass it. At this point both vehicles were south of the N Central Blvd and Church St intersection. As Gregory began to pass the Ford, the driver of the Ford suddenly and intentionally veered to the left as Gregory was passing and struck Gregory's car on the rear passenger side corner bumper.

This caused Gregory to lose control of his vehicle and spin. At this point Gregory's vehicle was sideways with his driver side facing the front end of the suspect vehicle. The suspect then accelerated and struck the driver side of Gregory's vehicle. Gregory's car came to rest in on a grass swale partially in and off the road way. The suspect then drove off.

The undersigned made contact with a witness, W/F Lauren Ramseyer (11/07/1986) who provided me with a sworn video recorded statement of the incident. Note the following statement is a





At the time, I was driving an unmarked Jupiter Police Department patrol vehicle (vehicle 1916), I was wearing a JPD uniform clearly identifying myself as a Jupiter Police Officer, and I was wearing my department-issued Axon body camera.</p> <p>While enroute, I was advised by NorthCom that a witness to the crash had called in to advise she had followed the suspect vehicle (gray Ford Fusion) from the scene of the incident to 5378 Pennock Point Rd. Jupiter, FL 33458. The suspect vehicle driver was described as a white male approximately in his 50s and the incident was initially described to dispatch as a road rage incident. I made contact with the witness via telephone while I was enroute to the scene of the incident and was advised that she believed the Fusion had intentionally "t-boned" a white Jeep.</p> <p>I arrived on scene and made contact with Officer Jurac, who was in the company of the Jeep and its driver (victim's vehicle). I advised Officer Jurac of the witness' statement to me via telephone and that I would drive to the aforementioned address in an attempt to locate the suspect.</p> <p>As I turned on Pennock Point Rd. from Loxahatchee River Rd., I was advised through a dispatch update on my computer that the suspect was observed by the same, aforementioned, witness leaving the residence in a gray BMW SUV. As I read this information, I observed a gray BMW X5 (SUV) pass me that was being operated by a white male in his approximate mid-50s. I followed behind the vehicle and ultimately conducted a traffic stop on N Central Blvd., just south of the intersection with Church St. The vehicle was slow to stop.</p>

<p>When the vehicle stopped, I approached on the driver side and made contact with the driver and sole-occupant of the vehicle. I identified the driver to be Gary Busch (w/m; 12/04/1959) by his valid Class E Florida driver license. Busch's eyes were bloodshot and glassy, he had slurred speech, and the odor of an unknown alcoholic beverage on his person. Initially when I made contact with Busch, he advised he had no knowledge of what occurred (although he had already passed by the damaged Jeep before the traffic stop was conducted).</p> <p>Due to the fact that the witness updated law enforcement with the suspect's approximate age and vehicle he was driving, I had reasonable suspicion that Busch was the driver of the vehicle involved in the road rage incident. I requested Busch step out of the vehicle and detained him in handcuffs behind his back. I advised Busch of his Miranda Warnings and confirmed he understood each one.</p> <p>Post-Miranda, Busch advised he was driving home from Uncle Mick's when an unknown vehicle approached him from an unknown direction that was engaging in "very, very, very dangerous vehicular driving patterns". Busch was unable to advise what was dangerous about the other vehicle's driving. Busch advised that the other vehicle was "riding my ass" and "swerving into me" but could not provide any other specific information about how the vehicle was swerving into him from behind his car. Busch advised there was "something I felt so threatened by" that he "had to take defensive action" with his vehicle. I asked what Busch did with his vehicle and he was unable to remember. Busch further advised he did remember that the unknown vehicle was "doing things that I felt I had to turn into them". Busch stated that his vehicle and the other unknown vehicle did make contact before he drove away.</p> <p>I clarified with Busch what vehicle he was driving from Uncle Mick's to his house and he advised he was driving a gray Ford Fusion. I remained with Busch while a show-up was conducted with a witness to the incident. When the witness arrived, Busch was positively identified as the driver of the gray Ford Fusion. See Officer Jurac's Probable Cause Affidavit for further information.</p>
