at approximately 9:55 PM, at 715 9TH AVE N SAFETY HARBOR, in Pinellas County did:

DID THEN AND THERE ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE MAGGIE WHITE AGAINST THE WILL OF MAGGIE, AND DID NOT CAUSE BODILY HARM.

MAGGIE STATED SHE AND THE DEFENDANT, WHOM SHE HAD BEEN SEEING ROMANTICALLY, ON-AND-OFF, FOR 15 MONTHS, BUT NOT COHABITATING, GRABBED HER ARMS FORCEFULLY AND PUSHED HER ASIDE. 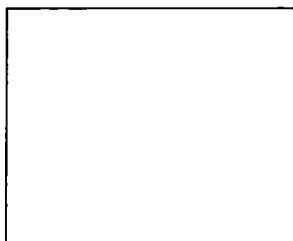
