The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was the driver of a black 2017 Range Rover bearing a Florida license plate NLNL19 and was stopped for driving the wrong way on a one-way street (W Cleveland St). Upon making contact with the driver he exhibited multiple clues of impairment, to include; glassy and bloodshot eyes, slurred speech, unsteady stance, strong odor of an alcoholic beverage and an admission to consuming alcohol. In addition, there was an open and empty can of White Claw alcohol in the center console cup holder in plain view. The defendant performed poorly on SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC of .218 and .224. The defendant was identified by his Florida driver's license.
