The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the listed date, time, and location, the victim and defendant were engaged in a verbal altercation within the kitchen area of the residence. The verbal altercation escalated when the defendant obtained a blue in color vase and threw it at the victim's feet. Parts of the vase struck the victim's left foot causing a visible red mark. The physical altercation continued from the kitchen to the living room, where the defendant pushed the victim with open hands in the chest area. The defendant pushed the victim again in the master bedroom, and again within the master bathroom adjacent to the master bedroom. All pushes were done so with open hands. The defendant also pushed his finger into the middle of the victim's head. The victim advised, she was pushed by the defendant numerous times, and that he threw the vase at her. The defendant did not wish to provide a statement post Miranda. The affiant observed a visible red mark on the top part of the victim's left foot. The affiant also observed a slight red mark on the top of the victim's forehead. The injuries appeared fresh. The victim and defendant have been in a romantic relationship for approximately one year and have lived together as a family during that time. The victim positively identified the defendant as the person who committed the offense. The defendant identified himself verbally and via his Florida driver's license. The defendant's identity was confirmed via D.A.V.I.D.
