The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 03/02/21 at approximately 2053 hours near 8331 Nebraska Av N officers observed a silver BMW, FL KWNC13, traveling north on Van Dyke Place towards Nebraska Ave. The vehicle pulled past the stop bar without coming to a complete stop and then while traveling north bound on Nebraska Ave, it swerved several times crossing the center line which resulted in a traffic stop. I approached on the driver side and immediately noticed the front passenger, Mark, was attempting to conceal an object in her waist band. Mark kept making furtive movements towards her waist and I instructed her to stop moving at which time I observed her drop a large piece of crack cocaine from her hand. She was subsequently detained and arrested for possession of narcotics (cocaine & marijuana) which led to a probable cause search of the vehicle and the driver, Gonzalez. Inside Gonzalez' wallet I located a clear plastic baggie containing a white powdery substance. Gonzalez identified the substance as cocaine and MPO Reudy also conducted a field test which resulted in a presumptively positive result for cocaine. Gonzalez was positively identified by FL DL and transported to booking.
