The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was stopped for speeding (80 MPH in a 55 mph zone), swerving and drifting over lane markers. The defendant was driving a 2018 Volkswagen 4Dr, bearing FL tag #PKMF36. Upon making contact with the defendant, she displayed multiple signs of impairment, including: a distinct odor of an alcoholic beverage on her breath, bloodshot/glassy eyes, a club admissions wrist band on her right wrist, and an admission to consuming alcohol. The defendant exhibited clues of impairment during the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .100/.095.

The defendant identified herself verbally, which was verified via her DAVID photo.
