The defendant was operating a blue 2016 Chevy Malibu, 4 door, Florida tag IBIV39. The defendant drove the vehicle in a manner in which she stopped for a green light, crossed onto painted lane markers, and crossed over painted lane markers twice. The vehicle stopped at a red light, at which time the passenger (co-defendant) exited the passenger side door and walked to the driver seat. The defendant slide over to the passenger seat. A traffic stop was conducted to check on the condition of the original driver to determine if she were sick, tired, distracted, or impaired. During the traffic stop, contact was made with the defendant, who had a distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed, and her speech was slurred. The defendant displayed some mild confusion, and forgetfulness. The defendant fumbled with documents and needed guidance from the co-defendant. The defendant wore a green colored bar admissions wrist band on her right wrist. The defendant admitted to drinking two alcoholic beverages tonight. The defendant also admitted to changing seats because she knew she was not okay to drive. The defendant swayed while standing. The defendant agreed to submit to Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and had difficulty following simple instructions. Based on a totality of the circumstances the defendant was arrested for DUI. The defendant provided breath samples of .140% BrAC and .145% BrAC. The defendant was positively identified by her Florida DL.
