On 01/08/2021, at approximately 2231 hours, I was conducting stationary traffic enforcement and sitting in the median of N Dale Mabry Hwy. I observed a white Jeep Grand Cherokee, bearing Florida tag LYHY97, to be traveling south on N Dale Mabry Hwy without any lights illuminated at night. I conducted a traffic stop on the Jeep Grand Cherokee at the intersection of N Dale Mabry Hwy and W Waters Ave. Upon contact with the defendant, she had bloodshot glassy eyes, unsteady balance and the distinct odor of an alcoholic beverage emitted from her breath as she spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which she agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI. Implied consent was read and the defendant refused to provide a lawful sample of her breath. The defendant was positively identified via her DHSMV photograph.
