The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

On the above listed date and time, at the above listed location, the defendant caused a traffic crash by rear ending a marked HCSO vehicle occupied by Corporal Menendez #140401. Upon contact with the defendant Corporal Mendez detected the strong odor of marijuana and noted the defendant was fumbling with the requested documents. Deputy Ross #129331 arrived on scene to conduct a traffic crash investigation (HCSO: 21-46236; DHSMV:89443699) where the defendant caused approximately \$100 in property damage. Deputy Ross observed indicators of impairment to include slurred speech and bloodshot eyes. Upon my contact with the defendant, I noted he had bloodshot, glassy eyes, body tremors, lethargic and an unsteady balance. Standardized Field Sobriety Exercises were conducted and impairment was observed. The defendant was arrested for DUI and agreed to provide a breath sample (.000/.000 BrAC). The breath sample provided by the defendant was not consistent with the indicators of impairment he displayed. The defendant agreed to provide a urine sample, which is pending analysis. Corporal Menendez positively identified the defendant as the person who operated the vehicle at the time of the crash. The defendant was identified by his DAVID photograph.
