The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 01 day of JUNE, 2020, at approximately 7:42 AM, at 1100 8TH AVE SW, in Pinellas County did:

DID THEN AND THERE INTENTIONALLY AND UNLAWFULLY THREATEN TO DO VIOLENCE TO ANDRE EASTON WHILE HAVING THE APPARENT ABILITY TO CARRY OUT SAID THREAT AND DID CREATE A WELL FOUNDED FEAR IN ANDRE EASTON THAT SUCH VIOLENCE WAS IMMINENT AND IN THE COMMISSION OF SAID ASSAULT DID USE A DEADLY WEAPON, TO-WIT: A ADULT SIZED HOCKEY STICK AND A LARGE METAL SOCKET WRENCH, A BETTER DESCRIPTION OF WHICH TO THE STATE ATTORNEY IS UNKNOWN, BY YELLING RACIAL SLURS WHILE HOLDING THE WEAPON AND WALKING WITHIN FEET OF THE VICTIM WHILE THREATENING TO DO HARM TO ANDRE EASTON WITH THE HOCKEY STICK AND A LARGE METAL SOCKET WRENCH. THE DEFENDANT AT THE TIME OF THE ASSAULT NOT HAVING THE INTENT TO KILL ANDRE EASTON.

TO WIT: THE VICTIM WAS A BLACK MALE AND RIDING HIS BIKE PAST THE DEF WHEN THE DEF BEGAN TO YELL TO THE VICTIM RACIAL STATEMENTS. THE DEF BEGAN TO YELL TOWARD VICTIM STATEMENTS SUCH AS "GET OUT OF THE PARK NIGGER" AND "YOU DON'T BELONG AROUND HERE NIGGER". THE DEF THEN WENT TO HIS VEHICLE AND PULLED OUT A LARGE METAL SOCKET WRENCH AND BEGAN TO THREATEN THE VICTIM. THE DEF ALSO GRABBED A LARGE ADULT HOCKEY STICK AND WHILE CONTINUING TO YELL RACIAL STATEMENTS AT THE VICTIM, REPEATEDLY BASHED IT INTO THE GROUND, RESULTING IN THE BLADE BREAKING. THE DEF THEN REPORTEDLY BACKED HIS VEHICLE, NEARLY STRIKING THE VICTIM. THE VICTIM RODE AWAY ON HIS BIKE AS THE DEF CONTINUED TO BACK UP. THE DEF THEN REPORTEDLY RAPIDLY ACCELERATED AND CONTINUED TOWARD THE VICTIM WHO WAS ON HIS BIKE. THE DEF CONTINUED TO YELL RACIAL STATEMENTS AT THE VICTIM AS HE BIKED AWAY. THE DEF WAS OBSERVED BY WITNESSES REPEATEDLY YELLING RACIAL STATEMENTS TOWARD THE VICTIM. DEF STATED THE VICTIM APPROACHED HIM AND HE "USED THE WEAPONS FOR SELF DEFENSE", BUT DID NOT HAVE AN EXPLANATION FOR WHY HE CONTINUED TO FOLLOW THE VICTIM UPON GETTING INSIDE THE VEHICLE. NFI

BASED ON THE PRESENT RACIAL DISCRIMINATION, I RECOMMEND THIS CASE BE RECLASSIFIED AS A SECOND DEGREE FELONY BASED ON FSS 775.085.

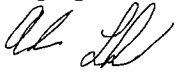

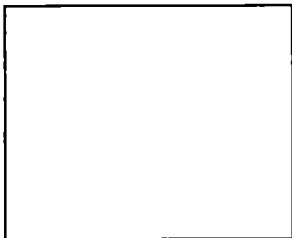
