On the above listed date, time, and location I responded to assist Dep. Gibb (ABN:257675) with a Traffic Crash with no injuries. Dep. Gibb made contact with the wheel witness who observed this truck with fresh damage on it reversing out of the property where this truck struck a tree. Dep. Gibb explained the wheel witness watch the defendant exit this vehicle to survey the damage to his truck. Dep. Gibb observed signs of impairment while conducting his traffic crash investigation. Dep. Gibb observed indicators of impairment to include bloodshot watery eyes, slurred speech, lethargic behavior, unsteady on his feet, and the odor of an alcoholic beverage emitting from his breath. Dep. Gibb completed the traffic crash investigation (DHSMV #89437556). I responded to the scene and made contact with the defendant. I observed the defendant leaning against his lifted gray 2012 Ford F-150 bearing FL tag #Y65LRF (VIN:1FTFW1EF8CFC06857). I observed indicators of impairment to include bloodshot watery eyes, slurred speech, unsteady on his feet, and the odor of an alcoholic beverage emitting from his breath. Post Miranda, the defendant admitted to consuming alcoholic beverages prior to driving. He admitted to drinking to much. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he agreed. During the first exercise the defendant showed signs of impairment. The defendant refused to perform the last two exercises. The defendant refused the opportunity to perform Standardized Field Sobriety Exercises after being advised that Standardized Field Sobriety Exercises are voluntary and that the exercises confirm or dispel any suspicion of impairment. However, if he refused to perform the following exercises, he could be arrested for suspicion of DUI based on the totality of the circumstances, and that his refusal to perform the requested exercises will be used against him in a court of law. The driver acknowledged the warning and he was arrested for DUI based on the totality of the circumstances. The defendant agreed to provide a lawful breath sample after a 20 minute observation period (BAC .235/.216). The defendant was identified via valid Florida driver license.
