The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was operating a black 2019 Nissan Altima, 4 door, Florida tag LYJG72. The defendant drove in a manner in which the vehicle drifted in the travel lane, with one of these drifting motions coming close to striking a parked vehicle on the side of the roadway. The defendant's vehicle tires crossed onto painted lane markers several times, and crossed over and straddled painted lane markers. The defendant drove at a visually estimated and patrol car paced (unit 5055) speed of 50-53 MPH in a properly posted 30 MPH speed limit. A traffic stop was conducted to check on the driver's welfare to determine if he were sick, tired, distracted, or impaired, as well as for unlawful speed. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed, and his speech was slurred. The defendant fumbled with his wallet, displaying dexterity problems, and he displayed cognitive problems as he forgot to look for other requested documents. The defendant denied alcohol consumption. The defendant was unsteady exiting the vehicle, and swayed while standing. The defendant agreed to participate in Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances he was arrested for DUI. The defendant provided breath samples of .147% BrAC and .132% BrAC. The defendant was positively identified by his Florida DL.
