UPON IDENTIFYING OURSELVES, AND EXPLAINING THE REASON WE WERE ON THE PROPERTY THE HOMEOWNER, REFUSED TO COOPERATE WITH THE INVESTIGATION EVEN THREATEN TO SHOOT AT DEPUTIES. 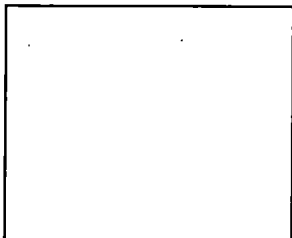
