During the vessel stop Atz was was not able to provide a whistle but was able to provide other safety equipment. During the vessel stop I could smell the odor of an alcoholic beverage coming from Atz. Atz had Modelo and Titos on the vessel. The vessel had multiple empty Modelos on the floor of the vessel. Atz had slurred speech and was not stable on the vessel.

I asked Atz to come aboard my vessel and he complied. I ask Atz if he had been drinking and he told me no. I advised him that I believed him to be under the influence of alcohol and ask him a second time and he admitted to drinking 1 or 2 beers. I ask him to perform field sobriety task, he complied and the results of the task were as follows:

The first task was the Horizontal Gaze Nystagmus
Lack of smooth pursuit in both eyes
Distinct and Sustained Nystagmus at Max Deviation in both eyes
Onset of Nystagmus prior to 45 degress in both eyes
Vertical Nystagmus was present

The second task was the Finger to Nose
Started at wrong time
Did not close eyes
Did not tilt head
Opened eyes during the task
Moved head during task
1st left - not fingertip and missed tip of the nose

1st right - Hesitated, not fingertip and missed tip of the nose

2nd left - no clues

2nd right - not fingertip

3rd right - not fingertip

3rd left - not fingertip
