The undersigned swears there are reasonable grounds to believe that the above-named defendant in Hillsborough County, Florida, did
The defendant and victim have been in an intimate relationship for approximately a year and a half and currently reside together at the above address in Tampa, FL. The female victim is five months pregnant with the defendant's child. On the above date and time the defendant and victim got into a verbal argument with the male defendant deciding to leave the female victim and vacate the premises with his belongings. The female victim provided law enforcement a sworn statement advising she made rude comments to the defendant while he was gathering his tools to leave. She stated the male defendant then grabbed a hammer and held it above his head in such a manner she believed he was going to hit her in the face with it. The female victim then advised she ducked out of the way and the male defendant dropped the hammer and pushed her with two open hands against a railing on the balcony.

The defendant in this case is personally known to the victim and she positively identified the defendant on scene via booking photo.
