The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 10 day of NOVEMBER, 2018, at approximately 3:57 PM, at 15TH AVE / GULF BLVD, INDIAN ROCKS BEACH, FL 33785, in Pinellas County did:

UNLAWFULLY HAVE IN HER ACTUAL OR CONSTRUCTIVE POSSESSION, A SUBSTANCE DEFINED BY FLORIDA STATE STATUTE CHAPTER 893, TO WIT: A CLEAR LIQUID SUBSTANCE THAT TESTED POSITIVE FOR METH. THE SUBSTANCE WEIGHED LESS THAN ONE GRAM.

DURING A TRAFFIC STOP THAT OCCURRED AT THE LISTED DATE AND TIME THE DEFENDANT WAS PLACED UNDER ARREST FOR DRIVING ON A SUSPENDED LICENSE WITH KNOWLEDGE. DURING WHICH TIME I ATTEMPTED TO COORDINATE WITH HER TO HAVE THE VEHICLE PICKED UP BY AN INDIVIDUAL OF HER CHOICE.

THE DEFENDANT REFUSED TO SPEAK WITH ME AFTER HER MIRANDA RIGHTS WERE READ TO HER.

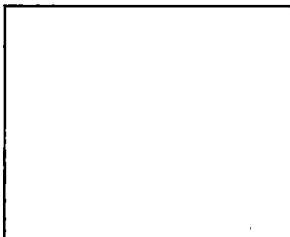
