The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did  
 On 07/21/2020, at approximately 1955 hours, at the Walgreens located at 11010 Bloomingdale Av, Riverview, FL 33578, the driver of a 2012 black Hyundai Accent (FL tag: QS084 / VIN: KMHCU4AE7CU069389) was observed asleep behind the wheel with the gear in drive. A needle with an unknown substance inside was observed inside of the defendant's right arm and a young child was in the backseat of the vehicle, attempting to wake the driver. Deputy Juncal #253879 attempted to wake the driver, at which time he put the vehicle in reverse, and collided with the curb. The driver eventually put the vehicle in park and excited. Deputy Juncal observed the driver to wake up and fall asleep multiple times. He also observed the driver to have severely constricted pupils and was slurring his speech. Field sobriety exercises and further indicators of impairment were observed, therefore, the defendant was placed under arrest for DUI. Due to no indicators of alcohol consumptions being present, I requested for the defendant to provide a urine sample, which he agreed to, however, after three hours of waiting, the defendant was caught attempting to pass water as a urine sample. The Implied Consent Warning was read when asked if he would provide a urine sample, he said, "No, I can't." The defendant was positively identified via his New York suspended driver's license.
