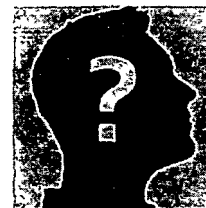

Before me this date personally appeared DEJEAN, CARYM (3721) who being first duly sworn deposes and says that on
13 day of April, (year) 2017 at [REDACTED] (crime location)
the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

the fight inside the residence, but continued to fight outside the residence. The defendant's actions affected the peace and quiet of person's who witnessed it and generated a large crowd of approximately 15 people to gather. One resident even intervened and pinned down the defendant to prevent the fight from escalating any further. Officers detained the defendant by placing him in handcuff restraints. While escorting the defendant to a marked patrol vehicle, the defendant pulled away and attempted to flee. The defendant immediately tripped and hit his head on a cement curb on the side of the road. Sunrise Fire Rescue responded and transported the defendant to Westside Regional for medical clearance. The medical staff at Westside Regional advised that the defendant was going to be admitted and placed in room ICU3. The probable cause affidavit was delivered to main jail along with his property.
