The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was stopped for violation of two stop signs and speeding (in excess of 50 MPH 35 MPH zone as paced by TPD calibrated Veh#113). The defendant was driving her 2013 Dodge 4dr, bearing FL tag #UWL4Z. Upon making contact with the defendant, she displayed multiple indicators of impairment, including: bloodshot/glassy eyes, dilated pupils, slurred speech, a strong odor of an alcoholic beverage on her breath, an odor of marijuana emanating from within her vehicle, and an empty container of Jack Daniel Honey whiskey on the rear floorboard of her vehicle. The defendant performed poorly on the SFSEs and was arrested for DUI. A search of the defendant's vehicle incident to her arrest and the plain odor of marijuana, revealed a Ziploc baggie containing about 5 grams of marijuana in the center arm rest console, along with a small metal herb grinder containing marijuana residue. A presumptive field test was positive for THC.

The defendant later submitted to the breath test, which had a BrAC of .141/.132.

The defendant identified herself via her FL driver's license.
