The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 10 day of JUNE, 2020

at approximately 9:35 PM, at 3980 TAMPA RD. OLDSMAR FLORIDA, in Pinellas County did:

ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE JOE KOVACS, WITH WHOM SHE HAS FOUR CHILDREN IN COMMON, AGAINST THE WILL OF JOE KOVACS, TO-WIT: BY PULLING HIS HAIR.

JOE KOVACS AND HAILEY ARMER WERE FORMERLY ENGAGED IN A ROMANTIC RELATIONSHIP. THEY HAVE FOUR CHILDREN IN COMMON.

ON 6-10-20 APPROXIMATELY 2135 HOURS, JOE KOVACS AND DYLAN BAILEY WERE IN THE BATHROOM OF THE HENNESSY'S BAR LOCATED AT 3980 TAMPA ROAD IN OLDSMAR, FLORIDA. THE TWO EXCHANGED WORDS BRIEFLY BEFORE BAILEY EXITED THE BATHROOM. ALMOST IMMEDIATELY, BAILEY RETURNED TO THE BATHROOM WITH HAILEY ARMER. ONCE INSIDE, BAILEY ATTEMPTED TO STRIKE KOVACS WITH A CLOSED FIST. THE TWO THEN BECAME ENGAGED IN A PHYSICAL FIGHT DURING WHICH KOVACS WAS ABLE TO STRIKE BAILEY ONE TIME IN SELF-DEFENSE BEFORE ARMER GRABBED HIM BY HIS HAIR AND PULLED ON IT.

AS ARMER HELD KOVACS' HAIR, BAILEY DELIVERED SEVERAL STRIKES TO KOVACS, WHICH HIT HIS HEAD ONE TIME, THE REST HITTING HIS UPPER ARMS AS HE USED THEM TO COVER HIS FACE AND HEAD.

DURING THIS INVESTIGATION, I OBSERVED RED MARKS TO KOVACS' FOREARM THAT APPEARED TO BE CONSISTENT WITH DEFENSIVE MARKINGS. BAILEY HAD AN ABRASION OVER HIS RIGHT EYE. ARMER WAS NOT INJURED. ALL PARTIES REFUSED MEDICAL ATTENTION.

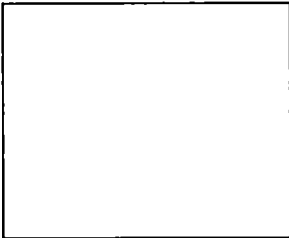
