Probable Cause Affidavit

Before me this date personally appeared POHORENCE STEVEN A (1936) who being first duly sworn deposes and says that on 22 day of April (year) 2017 at 2300 FLAS OLAS BLVD FORT LAUDERDALE, FL 33301 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

staff described the defendant as an Asian female driving a red BMW. I circulated the area and located the defendant traveling westbound on Las Olas Blvd. I began to pace clock the vehicle (FLPD 9510) driven by the defendant and observed her vehicle to be traveling 41 MPH in a posted 35 MPH zone As a result, I conducted a traffic stop on this vehicle

Upon making contact with the defendant via the front driver side window, I immediately detected an overwhelming odor of an alcoholic beverage emanating from her breath. In addition, I observed the defendant to have bloodshot watery eyes, and a flushed face. I requested the defendant provide her driver's license The defendant began to look for her license and passed it on two occasions before eventually providing it to me. I asked the defendant where she was coming from and she stated, "The W " I asked the defendant if she had anything to drink and she stated, "Yes" The defendant would not provide an amount she consumed Due to my observations of impairment I observed on the defendant, I requested she exit the vehicle for the purpose of conducting Standardized Field Sobriety Exercises The defendant performed poorly on all exercises I requested she do Due to the defendants poor performance, the observations of impairment I observed, it was my determination that the defendant was operating a motor vehicle while her normal faculties were impaired. I advised the defendant she was under arrest.

I transported the defendant to the BSO BAT facility for the purpose of a breath alcohol test Upon arrival, Deputy Williams 16345 asked the defendant if she was willing to provide a voluntarily breath sample. The defendant advised she would not. I then read the defendant Florida's Implied Consent warning on video in the BAT facility The defendant refused to provide a breath sample after hearing Implied Consent The
