The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
On 05/04/2021, at approximately 0502 hours, the affiant responded to the location of 1807 Princeton Lakes Drive Brandon, Florida 33511 Apartment 306 in reference to a domestic violence call for service. During the affiant's investigation, the affiant learned that on 05/04/2021 at approximately 0500 hours, the defendant walked into the bedroom where the victim was sleeping in bed. While inside the bedroom, the defendant became angry after searching through the victim's phone and woke the victim up by yelling and punching the victim in the right side of the face with a closed fist. The affiant observed swelling and bruising on the victim's right cheek and right side of the forehead above the eyebrow. The defendant and victim live together as a family in the state of Florida since August 2020 and lived together as a family in Massachusetts prior to moving to Florida. The defendant was identified by the victim. Both the defendant and victim were identified via their Massachusetts state identification cards.
