The following incident occurred in the City of Delray Beach, Palm Beach County Florida.

On 9/21/20 at approximately 2333 hours, I was dispatched to the area of SW 9th Avenue and SW 2nd Street in reference to a white female who was later identified as Hannah Oberton who was driving a white Nissan Sentra while intoxicated. While checking the area I called the complainant Craig Matthews who was on the phone with Hannah's mother Karleen Oberton who was tracking Hannah's location to the 300 block of SW 11th Avenue. I observed Hannah standing along her Nissan Sentra in the driveway of 313 SW 11th Ave which is a well-known and documented residence for street level narcotics sales.

While speaking to Hannah, I asked her if she had anything on her person. Hanna advised that she had a crack pipe and pulled the crack pipe from her rear pocket. I field tested the crack pipe utilizing a Lynn Peavey Cocaine test kit which tested positive for the presence of cocaine. Hannah was placed under arrest for possession of drug paraphernalia. While Officers were attempting to place Hannah into handcuffs, she began to pull away from and stated "I'm not going to jail" while pulling away. Officers were able to place Hannah into handcuffs.

Due to the facts stated above probable cause exists to charge the Defendant Hannah P Oberton with Possession of Drug Paraphernalia in violation of F.S.S. 893.147(1) and Resist Arrest without Violence in violation of F.S.S. 843.02
