NARRATIVE:

The Palm Beach County Sheriff's Office was notified on January 31, 2020 of an officer involved shooting at the presidential security detail in and around Mar-A-Lago, Palm Beach, Palm Beach County, Florida. The preliminary details were that a black Ford Jeep had breached the northern perimeter located at the intersection of S. Ocean Drive and S. County Road, Palm Beach, FL. The black Jeep had driven around the barricaded roadway and ignored orders to stop by uniformed PBSO deputies working the post.

The post was manned by Deputies Rohman and Carreiro. They observed the black Jeep with a smashed out driver side window being pursued by a marked FHP vehicle. Both vehicles continued southbound on S. Ocean Drive where the black Jeep continued at a high rate of speed running multiple barricaded areas. The black Jeep continued past a Secret Service Checkpoint until it encountered a barricaded area blocked by an unmarked PBSO vehicle.

Secret Service Agent [REDACTED] along with PBSO LT Harvey and Deputy Sheriff Farron encountered the black Jeep as it attempted to continue southbound by driving around the PBSO vehicle. The black Jeep causing property damage and aimed directly at Deputy Farron who had exited his vehicle and retreated into the driveway just west of his vehicle. At this time the black Jeep drove in the direction of deputy Farron and all three law enforcement officers discharged their issued firearms. Both LT Harvey and Deputy Farron were in fear for their safety and the safety of others. The vehicle continued fleeing southbound after being struck multiple times by gunshots. The



vehicle was lost by the pursuing FHP Officer on Southern Boulevard as continued westbound on Southern Boulevard.

Florida Highway Patrol Cpl. Deleeluw and PBSO tactical agents were able to locate the black Jeep a short time later. The black Jeep stopped 1551 Central Park Boulevard, West Palm Beach. The driver fled from the vehicle and was taken into custody as she was running up a staircase. A passenger in the vehicle was detained. The driver was identified as Hannah Roemhild, white female, 06/25/1989. The passenger was identified as her mother, Joanna Roemhild, white female, 10/28/1957.

Deputies Rohman and Carreiro arrived on scene and positively identified Hannah Roemhild as the driver of the black Jeep with the smashed out window as it ran their barricaded position located at S. County Road and S. Ocean Drive.

During the investigation I learned that Florida Highway Patrol Sgt. Tony Kingery was working an assignment at the Breakers Hotel located in Palm Beach, FL. Sgt. Kingery was contacted by staff and informed of a female acting erratically near the fountain of the hotel. Sgt. Kingery began giving commands to the female to exit her black Jeep. She was not complying with his lawful commands and began to place the vehicle into drive. As the vehicle was beginning to leave Sgt. Kingery deployed his ASP which had a window punch causing the window to break on the driver's door. The pursuit continued driving south on County Road at a high rate of speed with the driver ignoring all traffic control devices. It was this Jeep that was driven by Hannah Roemhild.

Based on the details of the investigation I find that Hannah Roemhild knew that law enforcement officers, LT Harvey and Deputy Sheriff Farron were engaged in the lawful performance of their duties when she knowingly and intentionally drove her black Jeep at them causing them to discharge their firearms in fear of their respective lives. This is a violation of Florida state statute 78 4.07 (2)(c).
